Here are a few **highlights** from the Pool Rules:

- ▶ **You must present your pool pass and sign in for each visit**
- ▶ **Unaccompanied guests are not permitted to use our pool**
- ▶ **Parties (6 or more guests at any one time): Proper advance arrangements must be made. See page 5 for full details on procedure.**
- ▶ **Children under 12 (both residents and guests): See page 2 and 3 for special procedures regarding swimming in the deep end and unaccompanied visits.**

The pool is for all, so please be courteous to your fellow residents and lifeguards while enjoying it this season. Thank you.

## Application for 2008 Fairlington Mews Recreation Pass

- APPLICATION.** Complete *and sign* the colored form and drop it by, or mail it to: David Biette and Ann Timmons, Recreation Committee, 4638 South 34th Street (Court 9), Arlington, VA 22206 by May 10, 2008 in order to receive your pass by the opening of the pool on Memorial Day Weekend.
- LATE?** We will accept late applications for recreation passes at the pool but will not be able to issue passes on the spot. Processing can take up to two weeks.
- TENNIS.** The combination for the tennis courts locks is on the back of the Recreation Pass.
- CHILDREN.** Children under the age of 12 do not need their own Recreation Pass since they must be accompanied by a resident with a valid pass  
→ UNLESS the child is at least 8 years old and has passed a 2008 swimming test with the lifeguard  
→ AND has submitted a SIGNED 2008 parental consent form.  
Once a child passes the swim test and the parent or guardian signs the consent form, the child will be issued a Youth Recreation Pass and may thereafter come to the pool unaccompanied.
- POOL RULES.** Detach the 2008 Pool Rules and Tennis Rules (on white paper) and keep them in a handy place. Turn in the application on colored paper.
